#### Description of Necessary First Aid Measures

#### Methods for Containment

**Small/Large Spill:**

Eliminate all ignition sources. Use only spark proof tools and equipment. Guard against static electrical discharges. - Engineering Controls:** Properly operating chemical fume hood designed for hazardous chemicals and having an average face velocity of at least 100 feet per minute. Provide an eyewash/shower station.
